This consolidated Price Support System is used to review and track systems, subsystems and components for systems such as the Automated Price Support System, Commodity Loan Processing System, Cooperative Marketing Association System, Electronic Loan Deficiency Payments System, Electronic Warehouse Receipts for Rice and Peanuts, Farm Storage Facility Loan Mainframe, Interim Market Gain/Loan Deficiency Payment Attribution Processing Application, Margin Protection Program for Dairy, Peanut Market Place and Data Collection, Reimbursement Transportation Cost Payment Program for Geographically Disadvantaged Farmers and Ranchers, State Office Reporting System, and the Trade Adjustment Assistance for Farmers Programs.
