	<p align="center">THE COMMODITY CREDIT CORPORATION RECORDS OF THE INTERNATIONAL WHEAT COUNCIL</p> <p>The Commodity Credit Corporation is a government-owned corporation established to help stabilize, support, and protect farm income and prices, to assist in maintaining balanced and adequate supplies of agricultural commodities and their products, and to facilitate the orderly distribution of commodities. In relation to these functions, the CCC collected records relating to the International Wheat Agreement of 1949 and the succeeding International Wheat Councils. The objectives of the IWA were to guarantee markets for wheat to exporting countries and supplies of wheat to importing countries at equitable and stable prices. Various officials from the Department of Agriculture served on the U.S. delegations to the councils. However, it was the function of the Department of State to serve as the secretariat for the U.S. in all international conferences. Therefore, the records of the IWA</p>
