Program Compliance Systems (PCS) are used to protect the integrity of the crop insurance program. This is achieved through a system of review, analysis and evaluation as to whether laws, policies and procedures are followed and administered correctly, and, the detection and prevention of crop insurance program abuse.

The systems are also used to identify possible areas of improvement in agency programs and to provide statistical information for standard reinsurance agreement negotiations.

This schedule includes systems such as the Compliance Case File Tracking System and the Strategic Data Analysis (Data Warehousing and Data Mining) systems.

**A. Compliance Case File Systems** are used to protect the integrity of the crop insurance program. This is achieved through a system of review, analysis and evaluation as to whether laws, policies and procedures are followed and administered correctly, and, the detection and prevention of crop insurance program abuse. These systems which include MAGNUM and CARS are used as a document repository and tracking mechanism for compliance investigator case files and materials from the court.

The system is also used to identify possible areas for improvement in agency programs and to provide statistical information for standard reinsurance agreement negotiations.</p>		
	<p><b>The system contains Personal Identifiable Information (PII).</b></p>		
1	<p><b>Inputs</b></p> <p><del>Insurance companies participating in the program provide crop insurance information to the RMA on program participants including producers, insurance agents, and loss adjusters. The crop insurance data contains personal identifiers that can be linked to program participants.</del></p> <p><del>The system uses digital maps from the Public Land Survey System registered by the Bureau of Land Management that depict public survey information, such as township locations referred to in legal land descriptions. Analysts use this information to determine whether there is a discrepancy between a producer's claim and land records.</del></p> <p><del>Public weather records from the National Oceanic and Atmospheric Administration to assist validating specific causes of loss for further investigation.</del></p> <p><del>Soil data from the USDA Natural Resources Conservation Service to determine whether soil on a producers land is acceptable for growing an insured crop.</del></p> <p><b>Disposition:</b> TEMPORARY Delete when data have been entered into the master file or database and verified, or when no longer needed to support reconstruction of, or serve as a backup to, the master file or database, whichever is later.</p>	GRS 20 Item 2(c)	
2	<p><b>Master File</b></p> <p>Data warehousing and data mining directly supports the RMA's Strategic Plan Objective which is to improve program integrity and to comply with the Agricultural Risk Protection ACT (ARPA) of 200. The ARPA requires the FCIC/RMA to use data warehousing and data mining technologies to identify producers, agents and adjusters that exhibit anomalous behavior and policy outcomes and to assist FCIC/RMA in improving the integrity of the crop insurance program.</p> <p><b>Disposition:</b> TEMPORARY Data will be retained in the system for a minimum of 25 years.
