Background Information

The LAWGS system collects Lacey Act declaration information during a self-registration process. This information is collected to combat illegal timber imports and protecting global natural resources. With the assistance of the U.S. Customs and Boarder Protection (CBP) Automated Commercial Environment (ACE) importers and formal customers will submit their Lacey Act declaration information using systems that are not owed or managed by APHIS. Once all information is captured the data is then moved to the Lacey Act Declaration Information System (LADIS) for storage by APHIS. APHIS personnel uses the information in LADIS to monitor compliance with the Lacey Act declaration requirements, identify trends in international trade, and alert to other Federal enforcements agencies of unusual or suspicious active.

Importers must submit Lacey Act declaration information based on products listed on the implementation schedule of enforcement of Harmonized Tariff Schedule codes. Using LAWGS, APHIS can quickly review the Lacey Act declaration information for accuracy and completeness to assist APHIS in verifying that plants and plant products imported into the United States are legally harvested, sold, and transported.
