Place maps

Geographic areas covered-
For incorporated and census designated places outside of MMS/VMS coverage, include, where present, boundaries of minor civil division (MCD's)/Census county divisions (CCD's), census tracts, and blocks or enumeration districts (ED's) within the place. The scale varies from map to map. All area covered by the place map is shaded on the county map, and the place map is considered to be an inset for the county map.

Metropolitan Map Series (MMS)/Vicinity Map Series (VMS)

Geographic areas covered-For urbanized areas and some other areas within SMSA's and adjacent non-SMSA's and adjacent non-SMSA counties and for selected urban concentrations outside of SMSA's show boundaries for urbanized areas, States, counties, minor civil divisions (MCD's) or census county divisions (CCD's), places, census tracts, blocks, and the few enumeration districts (ED's) that occur within MMS/VMS coverage. These maps are referred to as the Metropolitan Map Series (MMS) when the maps cover SMSA counties and as Vicinity Map Series (VMS) when the maps cover areas that are not in an SMSA. In some instances, these map sheets entirely cover a county and no separate county map exists. The predominant scale for the MMS and VMS is 1 inch equals 1,600 feet. In selected areas with very dense development, some sheets are at 1 inch equals 1,600 feet. In selected areas with very dense development, some sheets are at 1 inch equals 800 feet; conversely, some sparsely settled areas are reported at 1 inch equals 3,200 feet. As with the place maps, the MMS and VMS generally are considered insets to the county maps.

The following disposition applies to all items on this schedule:
