2 HIV/AIDS Surveillance Data Base

Contains a compilation of information from widely scattered small scale surveys. Information is compiled from those studies appearing in the medical and scientific literature, presented at international conferences and appearing in the press. The data base is updated twice a year and is cumulative.

Permanent - Transfer with the required documentation to NARA immediately upon approval of this schedule and every five years thereafter in accordance with 36 CFR 1228.188.

3 The Global Population Data Base

This data base is used to map populations of many countries of the world. The data base uses a rectangular grid for mapping of 20 minutes of latitude by 30 minutes of longitude (about 2,000 square kilometers at the equator). More detailed geographic based data is available for urban areas. Population data is primarily obtained through censuses, surveys, and maps from the Bureau of the Census library or from the countries themselves. The data base contains annual population projections and is cumulative.
