

2.	<p><u>Proclaimed List of Certain Blocked Nationals Country File-</u> arranged alphabetically by country name, and thereunder, alphabetically by name of firm or individual. The files document companies and individuals located in Central and South America whose accounts were frozen during World War II under the provisions of the " Trading with the Enemy Act. " The records were created by the Division of World Trade Intelligence, Department of State and collected by the Department of Commerce unit responsible for Proclaimed List operations during the War. The Office of International Trade Promotion, Bureau of International Commerce sent the files to storage. It was the successor to the Office of Trade Promotion, BFC cited above.</p> <p>The files consist of cable traffic, reports, and summaries compiled for the InterDepartmental Committee on the Proclaimed List. They are classified, SECRET, and their volume totals fifteen cubic feet.
