4. Market Share Reports, 1/1962-12/1971. 7 cubic feet. Accession 151-78-0019, boxes 1 and 2, Commodity File, are arranged numerically by report number. Boxes 3 and 4, Country File, are in no apparent order. Accession 151-78-0020, boxes 1 and 2 are not in good order, but there seems to be an attempt to arrange the Commodity Files numerically by the Standard International Trade Classification number. Box 3 is arranged numerically by report number, except that there are Country Files mixed in without a logical sequence.

Market Share Reports for specific commodities or countries. Each Commodity File report focuses on one commodity, providing the Standard International Trade Classification (SITC) number, technical notes to help the reader understand the reports and their limitations, and tables showing the destination, total exports from supplier countries, value, U.S. percentage of total, and the value of the exports of individual countries to the destination noted. For each destination the statistics are broken down annually over a six year period, i.e., 1962, 1963, 1964, 1965, 1966, and 1967. The value is noted in thousands of dollars. The destination countries do not appear to be a specific order.

The Country Files are similar to the Commodity Files, except that the tables are arranged by commodity number, rather than by destination country.

Computer printouts of country by commodity imports and exports for developed and less developed countries. Each printout shows the Standard International Trade Classification (SITC) or USSR number for the commodity, the name of the commodity, and annual

breakdowns of imports and exports in thousands of rubles and dollars. The reports are entitled "Project Trader: USSR Foreign Trade." "USSR Foreign Trade Data," or "ORR Foreign Trade Data." The reports contain similar information arranged in slightly different ways.

The application form (BDSAF-711C) includes the name and address of the company, a contact person, type and quantity of copper requested, the copper inventory of the company, anticipated receipts of copper from other sources, company requirements for production, anticipated shipments on authorized control material orders, company consumption of copper, company suppliers of copper, number of employees, and explanation of hardship reason for requesting stockpiled copper.

Related material includes an internal form used by the Copper Committee to approve the request, a copy of the form letter sent to the copper seller authorizing shipment of copper to the purchaser, and Form BDSAF-735, which reports deliveries of defense orders to companies.

The conferences were run with the help of local business leaders, including members of various Chambers of Commerce. Conferences were held at sites throughout the country including Oklahoma City, Cincinnati, Boston, Minneapolis, Seattle, Dallas, and Pittsburgh. Typical conference topics included Modernization - Key to New Markets and More Profits, How Objective is Industry, Warning Signs on the Road to Profits, Modernization Case Studies, Marketing, and Management.
