### **National Inventors Council Files**

The National Inventors Council (NIC) was established in 1940, under the Office of Technical Services (OTC), Department of Commerce to provide a clearing house for inventions that might be useful for national defense, and to bring to the attention of the armed forces. The NIC was most active during WWII but continued to solicit inventions into the mid 1950s. When OTC was abolished the Department of Commerce transferred its functions to the National Bureau of Standards; now the National Institute of Standards and Technology (NIST).

This schedule provides a one-time disposition for the remaining National Inventors Council files that are currently stored at Washington National Record Center.

##### **National Inventors Council Plans and Drawings 1940 - 53**

Files contain large drawings, blueprints, pictures, and handwritten notes from the original inventors; arranged alphabetically by last name of inventor.

The files were part of the inventors' original submissions and supplement the National Inventors Council Files scheduled under N1-167-99-01 that have been transferred to NARA.

##### **Incoming Correspondence of the National Inventors Council 1940 - 53.**

Files contain drawings, blueprints, and correspondence from inventor to National Inventors Council, copies of letters of regret and other correspondence from National Inventors Council to the inventors. All files relate to inventions that were not further evaluated or developed by National Inventors Council.

The files were part of the inventors' original submissions and supplement the National Inventors Council Files scheduled under N1-167-99-01 that have been transferred to NARA.

Permanent. Transfer to NARA immediately.

NIC files contain information subject to FOIA exemptions:

##### **b)(4) EXEMPTION - Trade Secrets, Commercial or Financial Information**

This exemption protects "trade secrets and commercial or financial information obtained from a person [that is] privileged or confidential." This exemption is intended to protect the interest of both the government and submitter of information.

##### **b)(6) EXEMPTION - Personal Information Affecting an Individual's Privacy**

This exemption permits the government to withhold all information about individuals in "personnel and medical files and similar files" when the disclosure of such information " would constitute a clearly unwarranted invasion of personal privacy." This exemption cannot be invoked to withhold from a requester information pertaining to the requester.
