The docket sheets and claims registers for all bankruptcy cases adjudicated are retained as are also orders affecting title to any real estate in these cases.

Item 2: These minor bankruptcy cases consist of petitions of debtors and creditors and any amendments thereto and schedules of assets and liabilities of the bankrupt. These cases are ordinary bankruptcy proceedings with assets above costs of administration but under \$500 available for distribution to secured, priority and unsecured creditors. These files do not have sufficient value for purposes of historical or other research, functional documentation or the protection of individual rights to warrant permanent retention by the Federal Government. The docket sheets and claims registers for all bankruptcy cases adjudicated are retained as are all orders affecting title to any real estate in these cases.
