[SF] SUBGROUP DESCRIPTION:

A Division of Regulations was created by the U.S. Shipping Board as early as May 1917 to enforce the regulatory provisions of the Shipping Act of 1916. By this act the Board was "to regulate carriers by water engaged in the foreign and interstate commerce of the United States."

The Division created regulations to govern the posting, publication, and filing of rates by interstate commerce carriers and the filing of traffic custodies and agreements by both domestic and foreign carriers. Hearings could be filed, if rates were found to be excessive; and the Board, on the basis of the facts, could make adjustments.

The Division analyzed conference agreements and freight and passenger tariffs, determined from questionnaires the shipping companies to whom the act applied, and held hearing on deferred rebates and the use of American vessels in the coastwide trades.







Only two units, the Division of Regulation and the Personnel Section, were exempt from these procedures and were allowed to maintain separate files.

The 8X10 inch black-and-white photographs contained in the 120-3 exhibit files are progress shots of vessels being built at various shipyards. Those taken at the Bethlehem Steel Sparrows Point Shipyard were photographed by A. Aubrey Bodine. Similar photographs are among the records in Record Group 32, Records of the U.S. Shipping Board (predecessor to the U.S. Maritime Commission), and are fairly active. A majority of the requests for these photographs are for inclusion in books and articles about vessels. Other frequent requests for the progress shots come from those who served on the vessels, and model builders.

#### [SD] [A4] JUSTIFICATION:

As is typical of most central correspondence files, these records demonstrate the major administrative activities of the U.S. Maritime Commission, War Shipping Administration, and the last days of the U.S. Shipping Board. Files concerning construction of liberty and victory ships, the operation of vessels under USMC and WSA control, labor relations at shipyards and on vessels, vessel casualties, and the use of asbestos during vessel construction, are all in demand by researchers. Indeed, the numerous out cards within the boxes and the constant pulling and refiling of the boxes by the NCWR staff during the time that these records were being reviewed for this appraisal demonstrate their unusually high research value.

However, some of the classes are of such an insignificant nature that they do not warrant retention. These include copies of publications readily available at government depository libraries, correspondence concerning office space and furniture, general office administration memorandums, and lists of executive orders and public laws relating to shipping.



The insurance functions of the Commission were recognized in 1937 with the creation of the Office of the Insurance Advisor. By 1941, this office had become the Division of Insurance.

Until 1942 this division handled all insurance matters for the Commission in connection with both the construction and the operation of the United States merchant fleet, providing special war-risk insurance for the protection of ships, cargoes, and crews under its direct control.

The division examined and approved all policies required by mortgages, by constructiondifferential and operating differential subsidy agreements, and by vessel-construction contracts. It arranged for insurance programs (workmen's compensation, general liability, automobile liability, and miscellaneous coverages) and procured or supervised and assisted in the procurement of such insurance for shipyards, transportation companies, and other contractors or agents of the Commission whose insurance premiums were direct items of cost to the Government. It collaborated with insurance companies and contractors for the adoption of safety measures in the shipyards. It collected and collated accident statistics; negotiated with company associations, bureaus, and state regulatory bodies for the purpose of controlling loss costs; and reviewed, analyzed, and approved or disapproved claims for losses.

In February 1942, the function of handling war-risk insurance matters in connection with the operations of the United States merchant fleet was transferred to the War Shipping Administration, where it remained until its return to the Insurance Division of the Maritime Commission in March 1946.

From 1939 to 1942 this division administered the contracts of the Commission relating to shipping and supervised the physical operation of vessels under the Commission's control. It supervised traffic activities and the solicitation of traffic for Commission-owned or -operated lines, and it cooperated with the Division of Regulation in maintaining agreements between shipping lines. It maintained general supervision of personnel on Maritime Commission lines, keeping service records, approvals of appointments, and a record of recommendations as to manning, wage scales, working conditions, and crews' quarters. The division also exercised general control over all stevedoring operations under the Commission; studied and made recommendations on the operating and traffic aspects of subsidy payments; supervised the drafting of operating provisions of charters, subsidy contracts, and managing agents' agreements; analyzed pooling agreements entered into by the Commission's managing agents; submitted reports and recommendations to the Commission on the necessity of trade routes; made reports on operating and traffic matters affecting passenger and cargo shipping; and gathered and made available to shippers and steamship lines data on world cargo and passenger traffic, routings, rates, and services available on various routes. Most of these functions for the period 1942-46 were transferred to the Assistant Deputy Administrator for Ship Operations in the War Shipping Administration.

Throughout the war the division was responsible for negotiating with the owners of such warehouses and storage properties as were required by the War Shipping Administration and the Maritime Commission and for reviewing all requisitions for gear and equipment necessary in the operation of such facilities. During the years 1944-45 it also began to make postwar plans and readjustments for the peacetime operation of the United States merchant fleet. Functions of the War Shipping Administration were transferred back to this division when that agency was abolished.



Administrative Order No. 12, dated November 20, 1936, and effective immediately, established the Division of Research. It was responsible for receiving, tabulating, and analyzing all information pertaining to the varied research problems of the Commission.

On March 28, 1941, Administrative Order No. 37 established the Division of Economics and Statistics, replacing the Division of Research and the Section of Special Studies. Its functions were twofold, to provide the Commission with economic and statistical data, analyses and recommendations, and to provide the U.S. shipping industry and the general public with relevant portions of this information.

In 1945, the division was designated the Division of Research and Statistics; by 1947 it was renamed the Division of Research.

Before WWII, this division was one of the most important in the Maritime Commission, one of seven divisions that had over 100 employees in the Washington office. Its main function was providing the facts on the basis of which the Commission determined what were essential trade routes and what level of subsidies was justified under the Merchant Marine Act of 1936. In addition, it made statistical reports as need arose on various other topics, such as the number of shipways active or available and the prospective labor supply.

During the war, the division's research in regard to the bases for subsidies ceased to be of immediate importance, and for a while it expanded its work on special statistical reports. In no case, however, did the division have direct access to the sources of statistical data; it worked with material received from the Customs Bureau, or the American Bureau of Shipping, or the Bureau of Labor Statistics, or divisions within the Commission.

With the growth of the divisions more closely connected to execution of policy, such as the Production Division, these operating divisions developed their own statistical staffs, which were closer to the sources of the statistical data and more closely in touch with the purposes for which the statistics were needed.

Although the division continued to make some special studies in 1943 on current problems, it increasingly turned to analysis of postwar policy and the long-range functions of the Maritime Commission. (Commentary from <u>Ships for Victory</u>, pp. 763-764)







This division was established by Administrative Order No. 37, Supplement 19, dated August 13, 1940, and effective immediately. Its function was to train men to become licensed officers of the U.S. merchant marine. It administered cadet training programs, including the U.S. Merchant Marine Academy at King's Point, New York. It also operated the U.S. Maritime Service (USMS), which had been created on July 14, 1938, by U.S. Maritime Commission General Order No. 25. The USMS, conducted with Coast Guard assistance, was a voluntary organization for training licensed and unlicensed personnel for American merchant vessels. Finally, the division supervised the training at state maritime academies partially supported by Federal funds.

The division succeeded the Section of Cadet Training, which had been supervised Commissioner Henry A. Wiley. In addition, the responsibilities of the Secretary of the Navy for administering grants of funds for the support of state marine or nautical schools, and maintaining vessels for the use of these schools, were transferred to the Commission by section 10 of Reorganization Plan IV, effective June 30, 1940.

Executive Order 9083, dated February 27, 1942, abolished the Division of Training in the U.S. Maritime Commission and transferred its functions to the Coast Guard. These functions were subsequently transferred to the War Shipping Administration by E.O. 9198, dated July 11, 1942. On January 1, 1947, the Division of Training was reestablished within the U.S. Maritime Commission.

As a result of these several reorganizations, the records of the maritime training function are very mixed in terms of provenance; few of the following series can be attributed to only a single creating entity.






