1	<p><b>Aeronautical Survey Files (Red Jacket/Cahiers)</b> Provides documentation to support Airport Obstruction Charts. These files are commonly referred to as "Red Jackets" or "Cahiers" and consist of aeronautical survey field notes, observations, triangulation diagrams, aerial photographs annotated with geodetic control data, copies of charts from the previous survey, and/or other relevant documentation. The files also include surveys of closed airports. Conducting aeronautical surveys is no longer a routine activity of NGS, however the files are still referenced for research purposes. The files created after 2014 are now maintained in electronic format.</p>
