Background Information NOAA's fleet of 16 research ships operate worldwide in direct support of NOAA's diverse environmental information collection programs, environmental stewardship services and applied scientific research. NOAA ships are operated by a combination of commissioned officers of the NOAA Commissioned Corps (a uniformed service) and civilian professional mariners in the Wage Marine job series, a class of prevailing-rate employees referred to by statute as "crews of vessels." The ships' officers and crew provide mission support and assistance to embarked scientists from NOAA laboratories and the academic community.

Within the Department of Commerce, NOAA is the only employer of these crews of vessels and has the independent authority to administratively establish basic and premium pay rates for the crews it employs. Pay rates are established under the authority of 5 USC 5348. These are maintained by NOAA / OHCS. These rates are adjusted annually based on changes in industry practices and Federal appropriations law.
