1. Seismograms

Historical seismograms dating up to 1971 for various locations in the United States prior to the establishment of the Worldwide Network of Standardized Seismograph Stations (WWSSN). Also includes seismograms recorded by stations participating in the WWSSN and international seismograms and World Registers submitted by foreign governments. In 1985, responsibility for seismic records was transferred to the U.S. Geological Survey. This schedule covers all extant records including those located at NARA Washington National Records Center (WNRC) and at NARA Rocky Mountain Region.
