Item 1 Bench Mark Descriptions/Points and Marks Descriptions, 1957-1992

The above dates refer to when the information was recorded onto description cards. The agency often designates the station founding date as the first year in a given accession.

These records describe monuments or other identifiable points for which elevations have been determined which are used as reference points for refining the geodetic grid. Information is recorded by agency employees on Forms 638, Description of Bench Marks. Recovery reports, instructions for locating the stations, miscellaneous notes and office computations are occasionally also included.

Because the electronic version became the official record copy in 1974, it is recommended that observations made after that date be considered for disposal during archival processing. (After 1974, all observations are recorded on input forms.)

Accession 370-86-0023 is recommended for disposal. These records are computer output used for edit/verification purposes.

The permanent records in this series are input prepared by NOAA personnel as a result of site visits which frequently contain narrative annotations. These are observations recorded on 5 inch by 8 inch description cards which the agency has designated as the official record copy of bench mark (point and mark) descriptions.

Item 8 Policy, Program and Planning Files, 1988

Offices submit detailed mission statements and how they seek to implement them in the course of requesting ongoing or additional appropriations. These contain valuable information which is not found anywhere else in accessioned or permanent records. For example, there is a notebook describing NOAA's Geodetic Resources Management Program which includes detailed discussions of its four branches. Also included is a substantial A-76 report describing the National Geodetic Survey Division.

Item 9 Civil Penalty Case Files, 1994-1996

Although DOL attorneys handle the files, DOL turns its official files back to NOAA's Bureau of Fisheries. These records include the official trial transcripts, hearing notices and relevant background and supporting information such as video tapes, charts and hand annotated informational files prepared by NOAA officials to assist the prosecution. These materials document not only how NOAA gathers evidence and decides what violations merit prosecution, they comprise the final chapter of Fisheries' mission which starts with research and instruction, continues with drafting and implementing regulations and ends with prosecuting the most egregious violators.

Item 10 Observation Network Management Files, 1971

These unscheduled records entered the WNRC under an exception letter dated 9/23/96 and deal principally with technical instructions for taking measurements in the upper atmosphere via flights originating from Vandenberg Air Force Base. In addition to listing some measurements that are subsequently transferred to NOAA data bases, there are also instruction notes concerning matters such as calibration and measurement accuracy.

Also included are multiple copies of operations manuals, most of which are in Spanish. These records contain not one word about the purposes of or reasons for these measurements.
