1.	<p>Deputy Assistant Secretary for Import Administration Office of Compliance Agreements Compliance Division Trigger Price Mechanism</p> <p><u>Preclearance Program Case Files</u> - created as a result of the reinstatement of the steel trigger price mechanism (TPM) effective on October 21, 1980 (45 F.R. 66833 dated 10-8-80). This program was initiated because the Department of Commerce recognized that there could be certain producers or exporters producing and/or exporting steel to the United States at prices below applicable trigger prices that were not at less than fair value. By requesting preclearance and cooperating with the Department's preclearance review of their production costs and pricing practices, foreign producers and exporters could avoid the risk of a TPM-initiated antidumping investigation.</p>

All steel products covered by the TPM Price Manual were eligible for such treatment. The program was terminated on November 5, 1981, when the Department determined that its resources could be better utilized in collecting data and examining steel imports for unfair trade practices than in verifying that individual companies were trading products fairly (46 F.R. 56843 dated 11-19-81).

The files are arranged in numerical sequence (e.g., .0001, .0002, .0003, etc.) and include the company name and the country in which the firm is located. Among the documents found are company requests for preclearance, completed preclearance questionnaires, company cost and price data, analyses and reviews of the data submitted, invoices, and related background information.

- a. Documents (regardless of their physical characteristics) submitted by companies and upon which no preliminary or final decisions have been made-- Return to the submitters when no longer needed for current business. } which have not resulted in case files...
- b. Closed Case Files:
 - (1) Documents submitted by preclearance applicants-- Return to the submitter when no longer needed for current business.
 - (2) All other case materials--Destroy when 2 years old.
