They are correctly identified as category 515 "Intelligence Data Base Records." Accessions contain studies on political population, environment, transportation, air defense districts and target complexes. A large amount of these records are graphics and overlays listed by B. E. number. Since none of these records have ever been recalled or researched in the last 15 years, this Agency requests they now be destroyed.
