Deleted, as these special investigative services records at HQ AFOSI and AFOSI field extensions are now included in Rules 15 and 15.1 and on occasion in proposed Rules 15.2 and 15.3. As these are investigative support records and are needed for frequent retrieval, current Rule 13 records are sent to HQ AFOSI staging area, not retired to WNRRC.	NC1-AFU-76-21	
2	Rule 15. Forensic services provided by an AFOSI regional forensic consultant are usually for significant investigations involving very detail case work. The description of these records in rule are changed, as Column A is for a short general description and Column B is for specific description of records. AFOSI Form 10, Forensic Science Statistical Data, was rescinded; remaining forms now included in "related records" in Column B description. Disposition is changed from 5 years to 15 years, since AFOSI Form 10 is rescinded, the rule will contain Rules 13 and 16 records (15 years), and these records are related to the specific cases of criminal records disposed of in Table 124-1, Rules 1 and 4. Rule 15.1. Covers same records as in Rule 15, but are kept at AFOSI field extensions. Disposition of these forensic services records is increased from 3 months to 1 year to meet possible inquiry needs from HQ AFOSI.

Rule 15.2. Changed, to cover records of "forensic services provided by AFOSI personnel other than regional forensic consultants." These forensic services are usually for regular type investigations that involve only minor support. The 3 year disposition is sufficient, as these records are also located in other records series, such as Table 125-1, Security Police records. Forensic service statistical data summaries, a 2 year record, no longer are produced and none are in HQ AFOSI offices.
