	<p>LEGAL ADMINISTRATION (Table 110-1) (Applicable Air Force-wide)</p> <p>The purpose of this submission is to revise Table 110-1 Rule 21 and add Rules 21.1 and 21.2. The rules pertain to records of US personnel tried by foreign countries. We receive approximately 500 foreign criminal jurisdiction cases each year. These include every significant case involving our personnel arrested and/or detained by foreign authorities. Of these, many result in trials by foreign courts and incarceration in foreign prisons. Last year 313 Air Force cases resulted in convictions; 96 trials resulted in acquittals. These cases include a variety of crimes to include: murder, rape, aggravated assault, sexual offenses, drug offenses, political offenses (desecration of national symbols), among others. Rule 21 pertains to cases having precedential or historical value, or otherwise generating high-level interest or concern. There will be about 10-25 cases per year for about 12 linear inches in space per year. Rule 21.1 are those cases that do not have precedential value, generate public, press or congressional concern. Rule 21.2 pertains to minor offenses.</p>
