1	PERSONNEL DATA SYSTEM--MILITARY (BASE LEVEL) (TABLE 30-4, RULE 15) (APPLICABLE AIR FORCE-WIDE)  We want to change the disposition of the System Change Requests records (AF Form 804) generated by HQ Air Force Civilian Personnel Management Center (HQ AFPCMC/DPCI) from "Destroy after 3 years" to "Destroy when no longer needed". The reason is that all AF Forms 804 reference the specific Air Force requirement that generates the system change along with any supporting background material which is maintained in the original 804 folder in AFPCMC. The office responsible for these records often refers to the 804s to determine why a specific edit, table change or Air Force program was systematically implemented. Active/inactive system change requests are constantly referred to when determining the feasibility of other new changes affecting the PDS-C. The present disposition allows the destruction of important information. By changing the disposition as proposed above, all change requests will then be screened individually and destroyed upon determination of the system requirement personnel.	N1-AFU-86-46
