	<p>MILITARY JUSTICE RECORDS (Table 111-1) (Applicable Air Force-wide)</p> <p>The purpose of this submission is to revise Table 111-1 Rules 27 and 28. These rules contain records used as a basis for imposing Article 15 punishment, and for making a determination as to the appropriateness of suspending, mitigating, remitting or setting aside punishment under Article 15, Uniform Code of Military Justice (UCMJ). Title 10, U.S.C. 1552 allows an individual to apply to the Board for the Correction of Military Records (BCMR) within three years after punishment is imposed under Article 15, UCMJ. This revision changes the retention period from one year to the three years allowed in 10 U.S.C. 1552.
