Needs clarification to eliminate confusion (see attached memorandum dated 9 Nov 95, with attachment for proposed disposition).</p> <p>JUSTIFICATION: We are unable to determine the arrangement, time frame, total volume, and yearly accumulation required for permanent records. The policy for Air Force Intelligence offices is to immediately turn over any captured records to the Defense Intelligence Agency for evaluation. This reduces the likelihood of any records possessed by the Air Force. However, if the Air Force should possess any captured records they would be transferred to NARA for permanent storage.</p>
