	<p align="center"><b>CHAPEL RECORDS (1949-1958)</b></p> <p>The purpose of this submission is to reduce the retention period for certain discontinued Chapel Records formerly designated permanent under the provisions of AFM 181-5 (1 Aug 54), para 423a; and AFM 181-5 (1 Nov 58), para 170117c.</p> <p>Records consist of AF Form 1271 and DD 421, Record of Funeral; AF Form 1272, DD Form 422 Record of Marriage; and AF Form 1273, DD 423, Record of Baptism; and comparable forms created by Air Force Chaplains during period 1949 thru 1958.</p> <p>Records are presently located in the Military Archives Division (1949-1955) and the Washington National Records Center (1955-1958).</p> <p>Recommend that a retention period of 50 years be established for subject records.</p>
