4	Rules 3 and 4. Technical nuclear safety analysis (TNSAs) are currently a portion of the Rules 1 and 2 documents. TNSAs describe the technical analysis of the weapon system design and operational procedures to determine if nuclear safety is adequate.		
4	Rules 5 thru 8. NWSSG safety study reports are currently a portion of Rules 1 and 2 documents. The report, consisting of the working draft, coordination draft, and approved report, is an executive summary of the safety study.
