Item 4 concerns records of the Miami Engineer District and relates to the Airport Development Program (ADP), 1942-1948. 176 cu. ft. of records from WNRC 077-50-0174 were previously accessioned into the National Archives of the United States under job N1-77-86-2.

**Disposition:** Permanent. Transfer to the National Archives in 2002.

**Justification:** Although reduced copies of these or similar plans appear in the ADP project reports and program history and folded copies are found in other accessioned ADP series, already accessioned into the National Archives, these Airport Plans are generally larger scale, easier to read, and often marked "as built." As such they supplement the accessioned records and provide a more detailed and complete graphic record of the projects completed under the Airport Development Program.

Submitted by engineer districts and divisions to document construction fortification progress against the hazards of bombing,

shell fire, flame, and related forms of attack. Also included are underground explosion test data files compiled by contractors.

**Disposition:** Permanent. Transfer to the National Archives in 2002.

**Justification:** This accession includes media that are not easily evaluated in record center storage space. The Special Media Archives Services Division will carefully evaluate these media and that office reserves the right to dispose of duplicate, unstable, or other records that do not warrant continued preservation by the Federal Government. That office may also choose to alter the format of certain records. It is assumed, however, that selected photographic, graphic, and textual records that document and analyze these tests will warrant continued preservation by the Federal Government.
