Justification: These records document nutritional studies conducted during demobilization of WWII. These records have been scheduled as permanent because of their significant historic and archival value.

2. **Student Nurse Individual Academic Records, 1919-1937.**

Individual student nurses summary record cards of courses taken and grades received and high school transcripts. Monthly record cards showing academic nursing subjects taken and ratings received for each year of study. Nursing curriculum entailed three years of study at different Army hospitals throughout CONUS. Also individual applications to the Army School of Nursing and assignments during courses of training.

Disposition: Permanent. Transfer to National Archives legal custody as Auxiliary Records for National Personnel Records Center (NPRC).

Justification: NPRC has been retaining all military academic records (Army 1912-1960; Air Force 1947-1963) for use in reconstructing military service records lost in the 1973 fire. These records have been scheduled as permanent because of their significant historic and archival value.

3. **Research and Development Progress Reports, 1946-1954.**

Medical research and development journals chronicling findings on subjects such as prosthetic devices, hospital equipment, radiology, surgery techniques, internal medicine, dentistry, basic medical science, and rescue and survival equipment.

Disposition: Permanent. Transfer to the National Archives in 2001.

Justification: These records document the type of medical research and development conducted in the post-WWII years. These records have been scheduled as permanent because of their significant historic and archival value.

4. **Armed Forces Epidemiological Board,
Commission Project and Manuscript files, 1954-
1965.**

Commission project and manuscript files containing epidemiological research studies conducted by university medical schools and funded by the Armed Forces Epidemiological Board. Research subjects include malaria, streptococcal and staphylococcal diseases, viral and enteric infections, and environmental hygiene.

Disposition: Permanent. Transfer to the National Archives in 2001.

Justification: These records document the type of investigations and control of infectious diseases conducted in the Armed Forces and would be of great interest to military and medical researchers and historians. These records have been scheduled as permanent because of their significant historic and archival value.
