

Justification: Routine, 0-99 - facilitative records concerning such subjects as how to write

a Military Police Report, requests for proposals for state legislation, memorandums relating to holidays. 100-199 - fiscal matters such as fund expenditures, planning for future budgets, and reimbursement voucher reports. 200-249 - personnel actions such as appointments, transfers, request for transfers, and wage schedules. 400-449 - procurement of supplies. 700-799 - Medicine - reports on sanitary conditions - very few records in these decimals. These decimals were also destroyed in previous accessions of central decimal files of the Office of the Chief of Transportation (NC3-336-80-1)

## **2. Subject Files**

Records relating to the establishment of freight rates (all under decimal 551.2). Freight ratings and classifications, information to be included on bills of lading, administrative records relating to the shipment of goods and equipment.

Disposition: Destroy immediately on approval of this schedule.

Justification: Shipping documentation and bill of lading information. Similar information may be found in the central decimal files.
