Records from Ft. Jackson and Ft. Monmouth illustrating intelligence gathering and reporting operations of the Army within the United States. Documents from Monmouth consist of reports on correspondence received from a variety of right-wing groups, with samples included. Records from Jackson document information received from visiting Argentinian officers on Argentina's views of the U.S., especially vis a vis the USSR, and reasons for those views, as well as data on socio-economic conditions in Argentina.

Permanent. Offer to NARA immediately upon approval of this schedule.

3. Counter-Intelligence Spot Reports, ca. 1955-64, 4 in.

Documents from Ft. Lewis and Ft. Gordon relating to intelligence and security activities. Records from Ft. Lewis consist mostly of correspondence on AWOL personnel with security clearances and AWOL alien personnel. However, they also include reports on a theft of ammunition; threats to a bi-racial military couple traveling in Washington; and a "Minuteman" poster on base glorifying the right-wing. Material from Ft. Gordon included no records specifically identified as spot reports. However, the files do contain 1955 trial records of alleged subversives in the military, and of former POWs in Korea accused of collaborating with the enemy. These records could be considered as a type of intelligence report. They do provide fascinating documentation of the ideological attitudes of the period.

Permanent. Offer to NARA immediately upon approval of this schedule.

4. Accident Report on Radiation, 1956, 1 in.

Detailed investigation from Ft. Monmouth on death of employee from alleged overexposure to radiation. File contains much data on use of film badges and on relative dangers of varying doses of radiation, and includes charts on exposure. The determination of the investigating board was that the death was not caused by radiation. The material documents scientific thought of the period on the relationship between radiation exposure and cancer.

Permanent. Offer to NARA immediately upon approval of this schedule.

5. Port Historical and Operational Files, ca. 1957-58, 1 in. 1204-01

Records from Camp Hanford consisting of correspondence and studies relating to the possible discontinuation of the Hanford Ferry. Documents show ferry usage and alternate routes and include maps of Hanford and of the area of Washington in which it is located. This material illustrates one unusual aspect of the installation.

Permanent. Offer to NARA immediately upon approval of this schedule.

6. AFAK Project Files, ca. 1954-55, 1 ft.

Records created by the Seoul Military Post documenting Armed Forces Assistance to Korea projects. Under this program, the Army built a variety of needed facilities for the Korean people, such as schools and orphanages. Each file contains project completion and progress reports, correspondence, blueprints and drawings, and budget data, all illustrating a non-combat role for the Army.

Permanent. Offer to NARA immediately upon approval of this schedule.

7. General Correspondence, ca. 1942-63, 803 ft.

AR 345-220/18D and other items in AR 345-200 series

Letters, memorandums, reports, and other correspondence relating to a wide variety of functions and subjects. The vast bulk of this correspondence concerns ephemeral transactions and procedures relating to the day-to-day activities of the creating unit, especially finance, personnel, training, and supply. This material is routine in nature and differs quite little from one installation to another. Despite the overwhelming banality of these records, there are certain items from most installations as well as unusual documents from specific creators that merit permanent retention. Almost all installations created historical reports; these are generally found in 314.8, but were sometimes filed in 319 or 0.4. Many installations prepared site plans and maps of the installation and/or of specific segments, such as port facilities or harbor defenses; these are filed most often in 600, 601, 680, 60, and 61, but may be found elsewhere in the decimal series. Some creators filed permanent series in the decimal system; these generally consist of command reports and operating program progress reports filed in 319, and will be separated out during the screening process.

In addition to these common permanent records, there are files created by specific installations which contain archival data not found in most general correspondence:

Vienna Military Post was involved with the four-power agreement governing Vienna and Austria after World War II, and its correspondence files contain data on relations with the USSR and the Austrian population. Although the correspondence is intermixed with disposable material, it can be identified and should be retained.

Fort Terry was used for research and testing in biological warfare, in conjunction with Fte Detrick Biological Laboratories. Unclassified general correspondence contains much data on buildings, animals, finance, and the site itself. The classified portion provides information on biological warfare agents, safety conditions, and logistical support. Because of the topic, all general correspondence files merit retention.

Camps Fuji and Whittington both had documents on Army relations with the local Japanese community. In file 334, Whittington has minutes of the Japanese-American Community Relations Council; file 463 from Fuji contains correspondence and maps relating to used oil from the Camp flowing into neighboring rice paddies. Both these files should be retained.

With some creators, a specific file within general correspondence defines the mission of the installation. This is the case with file 353.4 from Ft. Claybanks which documents the use of Claybanks as a firing range. Classified records from Ft. MacArthur consist of studies and maps on the mission of Camp Williams, Utah, and its suitability for infantry training. Since NPRC has no records from Camp Williams, this material from MacArthur should be kept.

While all the above-described records merit permanent retention, there are additional files that should be retained on a temporary basis because of their legal value. These records contain information on environmental concerns, and consist of documents on sanitation, building construction and demolition, waste disposal, decontamination efforts, and related matters. They are generally found in the 600 level of general correspondence, but may be filed elsewhere. A 50-year retention should be sufficient for any possible legal needs.

The term General Correspondence is applicable not only to centralized General Administrative Files, but also to specific administrative files maintained by individual offices. This item is not applicable to those individual files which document long-range planning, organizational, and policy matters, and which have previously been scheduled for permanent retention. In addition, this item is not applicable to specific series or portions of administrative files described and provided for elsewhere in this schedule.

a. All historical reports, filed in 314.7 or wherever; all maps and site plans, filed in 600, 601, 680, 60, 61, or wherever; all records from Vienna Military Post and Ft. Terry; classified records from Ft. MacArthur; file 334 from Camp Fuji; file 463 from Camp Whittington; file 353.4 from Ft. Claybanks; and similar records wherever found. *records filed under 660.2 and 662 pertaining to coastal' defense and/or anti-aircraft missile batteries.*

Permanent. Offer to NARA immediately upon approval of this schedule.

- b. Correspondence on sanitation, building construction and demolition, waste disposal, decontamination efforts, and related matters, in the 600 level or wherever filed.

Temporary. Retain at NPRC for 50 years. Destroy in 2036.

- c. All other records.

Destroy immediately upon approval of this schedule.

8. Intelligence General Correspondence, ca. 1950-64, 9.6 ft. 501-01

Letters, reports, memorandums, and other correspondence from most installations relating to the variety of intelligence functions performed by installations. The vast bulk of the material is routine and ephemeral in nature, pertaining to security clearances, investigations, inspections, classification, and lists of foreign-born military personnel. Also included, however, are more valuable documents, such as Intelligence SOP's from Fort Wayne; data on the receipt of racist and anti-Semitic literature at Ft. Chaffee, as well as correspondence on the visit of a Soviet diplomat to Arkansas; and correspondence from Camp Kobe on the handling and effects of a strike by Japanese workers. The security-classified portion of the series contains a command program for intelligence activities at Ft. Lewis, reports from Ft. Jackson on visits of Austrian and Turkish officers, what they wanted to know, and what was learned from them; and lists from Ft. Bragg of individuals considered security risks, but with no reasons given.

- a. Security classified records from Fts. Lewis and Jackson; non-classified material from Fts. Wayne and Chaffee; records from Camp Kobe on labor difficulties.

Permanent. Offer to NARA immediately upon approval of this schedule.

- b. All other records.

Destroy immediately upon approval of this schedule.

9. Training General Correspondence, ca. 1951-64, 5.3 ft. 1001-01

Letters, reports, memorandums, and other correspondence from a variety of installations relating to the day-to-day activities of training sections. The vast bulk of this correspondence concerns routine and ephemeral transactions and procedures, such as tables of organization and equipment, foreign students, course schedules, and the administrative aspects of operating a training program. However, records retired by Ft. Greely all relate to training given by the Cold Weather and Mountain School, and include data on exercises, and tests of uniforms and equipment. These document the training necessary for military activities in conditions of extreme cold.

- a. Records from Ft. Greely.

Permanent. Offer to NARA immediately upon approval of this schedule.

- b. All other records.

Destroy immediately upon approval of this schedule.

- 10. Memorandums, ca. 1947-62, 75.5 ft.

227-01

Numbered and unnumbered issuances from most installations in print, near-print, or typescript form, used for a variety of purposes, but generally for prescribing routine, short-term administrative procedures. However, certain numbered memorandums include site plans of the installation; these consist of memos designating fire and police areas, or outlining defense plans for the installation. While the memorandums themselves are totally routine in nature, the maps they contain may be the only ones extant for a given installation. Also, classified memorandums from Killeen Base contain instructions on the assembly and shipment of atomic weapons; these should be retained for the data they provide on the weapons and on shipping procedures.

- a. Classified memorandums from Killeen Base; maps contained in police, fire, and defense plan memorandums.

Permanent. Offer to NARA immediately upon approval of this schedule.

- b. All other memorandums.

Destroy immediately upon approval of this schedule.

- 11. Letters, ca. 1951-63, 8.5 ft.

227-01

Numbered and unnumbered near-print and typescript issuances created by most Army installations to provide information to lower echelons or to all personnel on routine, housekeeping activities of the installation such as supply, safety, or personnel matters. Some are newsletters, containing the types of mundane information generally contained in daily bulletins. The only exception to this banality may be found in mission letters from the Poitiers Installation; these define the mission of the organization and include maps showing the mission area.

- a. Mission letters.

Permanent. Offer to NARA immediately upon approval of this schedule.

- b. All other letters.

Destroy immediately upon approval of this schedule.

12. Bulletins, ca. 1946-64, 58 ft.

227-01

Numbered issuances from almost every installation used to convey official and unofficial information of an advisory, informative, or directive nature. Issued by a variety of offices for routine, generally short-term purposes. The bulk of the series is composed of daily bulletins, but also included are range, safety, personnel, and ordnance technical bulletins; the last of these contains maintenance procedures and listings of spare parts. The only bulletins containing any significant data are monthly statistical bulletins, issued by several installations. These show post activities and are similar to, though not as complete as, operating program progress reports.

- a. Monthly statistical bulletins.

Permanent. Offer to NARA immediately upon approval of this schedule.

- b. All other bulletins.

Destroy immediately upon approval of this schedule.

13. Manuals, ca. 1951-67, 4.7 ft.

227-01

Printed issuances, from many installations, used for a variety of purposes, such as prescribing uniform policies and procedures; establishing programs; describing organizational structure; listing responsibilities and functions; listing supplies and equipment; setting maintenance and repair procedures

- a. Manuals containing policies and responsibilities; organization and function; significant procedures; or important information.

Permanent. Offer to NARA immediately upon approval of this schedule.

- b. All other manuals.

Destroy immediately upon approval of this schedule.

14. Guides, ca. 1951-63, 10 in.

227-01

Printed issuances from a variety of installations used to establish installation policy and procedure, or organization and function, provide data on activities performed, or set forth routine security, personnel, or training policies.

- a. Guides establishing policy and procedure, or organization and function, or providing significant information on the installation.

Permanent. Offer to NARA immediately upon approval of this schedule.

- b. All other guides.

Destroy immediately upon approval of this schedule.

15. Facilities Control Files, ca. 1951-62, 9.4 ft.

Documents from a variety of installations relating to land and building requirements and utilization, repair and utilities, inventories and inspections of buildings, and similar matters relating to installation activities. Much of the material relates to routine activities, such as surveys on equipment, building, and utility use, or correspondence on specific buildings, such as theaters or sports facilities. Records from some installations do include excellent site plans, often with maps of water, sewage, and electrical lines. Ft. Miles and Camp Kobe were among those creating these plans.

- a. All site plans and maps.

Permanent. Offer to NARA immediately upon approval of this schedule.

- b. All other records.

Destroy immediately upon approval of this schedule.

16. Procedural Standardization Files, ca. 1951-62, 11.6 ft. 216-03

Documents relating to the analysis and prescribing of specific work procedures at most installations. Some of the material consists of published regulations and SOP's, often in manual form. Other material is composed of background papers for these printed issuances, such as work simplification proposals, management improvement and survey files, flow charts, and personnel utilization reports.

- a. Records consisting of printed SOP's or regulations.

Permanent. Offer to NARA immediately upon approval of this schedule.

- b. All other material.

Destroy immediately upon approval of this schedule.

17. Alien Reports, ca. 1954-61, 4 in.

Records from Ft. Monmouth and Ft. Bragg listing alien and foreign-born military personnel with date and place of birth, language proficiency, etc. The major concern was with those born in Eastern Europe, and related to a fear of defection of personnel. Security-classified records from Ft. Monmouth also list civilian personnel, with date and place of birth, position, grade, clearance, and naturalization number, if applicable. Most of these civilian employees were German scientists born in the early years of the twentieth century; it is probable that some of them worked for the German government during World War II.

- a. Security classified alien reports of civilian employees at Ft. Monmouth.

Offer to Office of Special Investigation, Department of Justice. If offer declined, then destroy.

b. All other records

Destroy immediately upon approval of this schedule.

18e Security General Correspondence, ca. 1951-62, 10.8 ft., 501-01

Letters, memorandums, reports, and other correspondence relating to the routine administration of security violations, inspections, and classification activities. The vast bulk of this correspondence concerns ephemeral transactions and procedures relating to the day-to-day operations of the security sections at most installations, such as the handling of classified material, the regrading of security classified documents, and the processing of individual security clearances.

Destroy immediately upon approval of this schedule.

19. Hospital and Dispensary Correspondence, ca. 1950-58, 27.2 ft., 901-01

Letters, reports, memorandums, and other correspondence created by hospitals and dispensaries at most installations. Generally, the records document the day-to-day activities of the creating unit, and consist of routine material relating to physical examinations, requests for records, insurance, inspections, supplies and equipment, polio vaccine, and veterinary hygiene reports.

Destroy immediately upon approval of this schedule

20. Sanitary General Correspondence, ca. 1951-57, 2.3 ft.

Letters, reports, memorandums, and other correspondence from various installations relating to the routine administration of sanitation activities. Included are materials on preventive medicine, data on food-vending machines, and sanitary inspection reports on installation messes and food establishments in the area.

Destroy immediately upon approval of this schedule

21. Pamphlets, ca. 1953-65, 11 in., 227-01

Numbered and unnumbered print and near-print issuances from a variety of installations and consisting, generally, of routine administrative information. Many of the pamphlets are merely indices of publications and forms, supply lists and catalogues, or transmitters of housekeeping information.

Destroy immediately upon approval of this schedule

22. Circulars, ca. 1951-65, 23.2 ft., 227-01

Numbered issuances created by most installations, in print and near-print form, for the purpose of providing operating instructions for

the implementation of regulations. The information promulgated is generally routine and transitory in nature. None of the circulars, regardless of creator, contained anything of historical or evidential value.

Destroy immediately upon approval of this schedule.

23. Directives, ca. 1951-64, 4 ft. 227-01

Numbered, near-print issuances of many installations prescribing routine administrative procedures relating to training, budget, management, and performance analysis. Weekly directives are similar in function to daily bulletins; some directives are similar to movement orders. None document significant installation activities.

Destroy immediately upon approval of this schedule.

24. Training Notes, ca. 1954-58, 5 in., 227-01

Printed issuances from Ft. Carson and Camp Tortuguero containing routine administrative instructions relating to training, such as scheduling classes, handling trainees, and planning a graduation ceremony.

Destroy immediately upon approval of this schedule.

25. Intelligence Reports, ca. 1951-59, 6 in., 502-01

Documents from Ft. Lee, Camp Garry, and Camp Kobe consisting of routine reports on clearance and records classification, reports of visits by foreign nationals, and lists of military personnel with special language or intelligence work qualifications.

Destroy immediately upon approval of this schedule.

26. Guided Missile Planning and Reports, ca. 1955-58, 6 in.

Records from Ft. Meade consisting only of Guided Missile Failure Data Reports and transmittal sheets for them. These reports document problems with guided missiles, generally the components thereof, and concern leaks, battery failures, and similar difficulties.

Destroy immediately upon approval of this schedule.

27. Ordnance Technical Training Narrative Reports, ca. 1955-58, 6 in.

Records from Ft. Meade consisting of monthly reports of inspection of missile equipment and repair work, and of results of training in the repair of missiles. The material is quite similar to training inspection reports which are already disposable (AR 340-18-1002-03).

Destroy immediately upon approval of this schedule.

28. Memorialization Board Files, ca. 1961-62, 2 in. 228-11

Records from Ft. Riley and from Indiantown Gap Military Reservation concerning street names for the installation and the dependent housing area. Included are lists of street names and related correspondence.

Destroy immediately upon approval of this schedule.

29. Censorship Files, 1963, 1 in., 512-01

Correspondence from Ft. Chaffee relating to the issuance of censorship stamps to the various units at the installation.

Destroy immediately upon approval of this schedule.

30. Realty Historical Files, ca. 1958-61, 2 in. 1504-05

Records from Ft. Crowder concerning the transfer of buildings to the local school district, and repair and maintenance of installation facilities. Though scheduled with a disposition of C2035, these records contain nothing of archival value. Also, Ft. Crowder created 8 in. of Master Planning Files, previously appraised as permanent, for the same period; these document the physical history of the installation far better than these Realty Historical Files.

Destroy immediately upon approval of this schedule.

31. Medical Daily Diaries, ca. 1951-63, 3.5 ft., 902-03

Documents created at various installation hospitals and dispensaries and consisting of patient registers, reports of professional officer of the day, inspection reports, personnel rosters, lists of ambulance calls, or similar, routine materials.

Destroy immediately upon approval of this schedule.
