Background Information

AR 702-6, Ammunition Stockpile Reliability Program, prescribes policy, responsibilities, and guidance on the Ammunition Stockpile Reliability Program (ASRP). The ASRP provides "cradle to grave" responsibilities, to include demilitarization, for monitoring the performance, reliability, and safety characteristics of ammunition items and class V components. This program applies to conventional and chemical ammunition, small and large rockets, guided missile ammunition, and associated materiel. The proponent for this regulation is the Deputy Chief of Staff, G-4 and has primary staff responsibility for identifying all munitions, equipment, and materiel requirements.

In support of the war-fighter, the LCMS-RMLS web application supports the U. S. Army Aviation and Missile Research Development and Engineering Center (AMRDEC), the Precision Fires Rocket and Missile Systems (PFRMS) Project Office, the U. S. Marine Corps (USMC) and the Joint Attack Munitions Systems (JAMS) Project Office.

The system includes four modules:

Logistic Module is used to track inventory of rocket, Missile, and Launcher assets to include Status, Condition, Age, Shelf Life, Location and Active/Expended Quantities, inclusive dates are 1990 to present.

Maintenance Module is used to track maintenance and repair actions performed on Rocket and Missile assets and to provide analysis tools to help identify failure trends, inclusive dates are 1993 to present.

Product Assurance and Test (PA&T) Module is used to determine the reliability of rockets and missiles in the field, inclusive dates are 2002 to present.

Joint Attack Munitions Systems (JAMS) Module is used to track failure review actions, inclusive dates are 2008 to present.

The system supports Precision Fires Rocket and Missile Systems (PFRMS) Project Office, Letterkenny Munitions Center, Aviation and Missile Research Development and Engineering Center (AMRDEC), and JAMS Project Office.

Source input data is imported from bulk data inserts, maintenance technician, official test reports and covered under RN 25-1kkk.

Automated system administrative outputs and reports use RN 25-1lll.
