Background Information

AR 70-1, Army Acquisition Policy, implement the Army's acquisition policy for programs in acquisition categories (ACATs) I through III. This regulation assigns responsibilities to Army organizations in accordance with DODD 5000.01 and DODI 5000.02. The Army will apply the direction contained in DODD 5000.01 and DODI 5000.02 to all acquisition programs while streamlining and tailoring the procedures within statutory and program requirements. This regulation also specifies Army's acquisition workforce management responsibilities and defines clothing and individual equipment (CIE) acquisition responsibilities. The proponent of this regulation is the Assistant Secretary of the Army for Acquisition, Logistics, and Technology (ASA(ALT)). In support of AR 70-1, ASA (ALT) submits for disposition the PM Soldier Weapons Collaborative Data Environment (PM SW-CDE). PM SW-CDE is a collaborative data environment system that provides a seamless environment to execute, manage, and organize data related to the acquisition of new and existing weapons systems. It allows for enhancing communication/interaction of the program personnel regardless of physical location; and organizes and manages acquisition and developmental data for the duration of the appropriate lifecycles of the weapons systems. The inclusive dates of PM SW-CDE records are from 2005 to present. Outputs are covered under RN 25-1jjjjj, Source input is keyed into the system manually by users and is approved for disposition under RN 25-1kkk. System documentation includes record layouts, specifications, and code books which are covered under RN 25-1mm.
