Background Information **The Food Service Management Program (FSMP)**
AR 30-22, Army Food Program prescribes policies, responsibilities, objectives, and standards for the implementation and management of Army subsistence and food service programs in garrison, field, and contingency operations.
The proponent of this regulation is the DCS, G-4. In support of AR 30-22, the Army Materiel Command, Ft Benning, GA submits for disposition the Food Service Management Program (FSMP). The FSMP application is used to inspect dining facilities, record results on handheld tablet computers and upload data to a master database. The program provides the user with a means of entering the results of a dining facility inspection and storing the data. The application generates and schedules random dining facility inspections.
The inclusive dates of FSMP records are from 2001 to present. Source input is manually entered on handheld tablets by government quality assurance evaluators (QAE) via typed entry and is approved for disposition under RN 25-1kkk/400B. System documentation includes record layouts, specifications and code books which are covered under RN 25-1mmm/400B.
Output: the Food Services Management Program produces a plethora of reports indicating the quality of the performance of the Food Services contractor, as rated by the evaluation of Government QAE's. Individual inspection reports, monthly quarterly and yearly summary reports are generated by the system and are used by the COR to compute the contractors performance rating. Automated system administrative outputs and reports use RN 25jjjj/400B, Information Technology.
