### Background Information

AR 600-85, The Army Substance Abuse Program, provides comprehensive alcohol and drug abuse prevention and control policies, procedures, and responsibilities for Soldiers of all components, Army civilian corps members, and other personnel eligible for Army Substance Abuse Program (ASAP) services.

The proponent of this regulation is the Deputy Chief of Staff, G-1. In support of AR 600-85, The U.S. Army Medical Command submits for disposition the Forensic Toxicology Drug Testing Laboratory – IMS system. (FTDTL-IMS).

FTDTL-IMS provides a database to automate the tracking and documenting of urine specimens through the drug testing and validation process from the time the urine specimen is taken until final disposition of the specimen. FTDTL-IMS supports the DoD drug deterrence program for the readiness of the military forces and operates in facilities/units of the Drug Deterrence Office.

Source input originates at world-wide collection sites for each unit/base. Barcodes are scanned and data is keyed into FTDTL-IMS at the DoD Drug Testing Laboratories and are approved for disposition under RN 15-1kkk. System documentation includes record layouts, specifications, and code books which are covered under RN 25-1mmm.

Output for the FTDTL-IMS system contains: Drug Testing results.

- Laboratory testing reports and forensic documentation
- Electronic data files are provided to ADMITS, DAMIS, DMDC and are approved for disposition under RN 25-1jjjj.
