Background Information AR 750-1 establishes policies and assigns responsibilities for the maintenance of Army materiel as it applies to maintenance of all materiel owned or supported by the Army. The proponent of this regulation is the Deputy Chief of Staff, G-4. In support of AR 750-1, the Army Materiel Command/Army Materiel Systems Analysis Activity submits for disposition the Consolidated Equipment Data Review Application (CEDRA). CEDRA is a research and analysis system, based on custom developed software. This system collects, verifies and corrects weapon system usage and maintenance data on ground and air vehicles.
