	<p><u>Army Criminal Investigation Reporting System (ACIRS III+)</u></p> <p><b>BACKGROUND AND ADDITIONAL INFORMATION:</b> Agency - United States Army Criminal Investigation Command (CIDC). ACIRS III+ is a world wide criminal investigative reporting system that is used in both a peacetime and wartime environment. It is a computer based Telecommunications and Automated Information System (TAIS) for the collection and reporting of criminal investigative information from 130+ worldwide field activities to USACIDC. This system consists of a database containing information about Criminal Investigation Division (CID) reports of investigation. The database is never over written. An Agent can always retrieve up to 5 previous status and instances data entries at any time The said updates are system contained. The description below applies to masterfiles and output reports generated by ACIRS III+. Authorized users are primarily USACIDC agents. Information about the said database, inputs, outputs, backups and system documentation is attached. The governing directive for the ACIRS III+ is AR 195-2.</p> <p>a. Source of data for the system: The information, meaning the Report of Investigation (ROI) which contains information related to serious crimes and incidents investigated are keyed into the system by authorized users. The input records/application from these ROIs provide a total of 340 data input screens for data capture. Certain data elements from criminal investigation reports of investigation are from Military Police Reports (MPR's) which are entered into the system.</p>
