Subjects were volunteers (military members, Federal civilian employees and state prisoners) who participated in Army tests of potential chemical agents and/or antidotes from the early 1950's until the program ended in 1975. Individual research/test/medical documents are also contained in an individual's health record. Records may exist in paper, microfiche, historical 16mm film and audio visual tapes. The records are protected by PA System Notice A0040-31bDASG.
