	<p>GROUPS OPERATIONAL PASSENGER (GOPAX) REPORTS</p> <p>Background Information GOPAX supports the Mobility Control Center (MCC), United States Transportation Command (USTRANSCOM), Directorate of Operations, Headquarters Military Traffic Management Command (HQMTMC), and United States Army Material Command (AMC) in the arrangement and procurement of transportation support for DoD group passengers GOPAX supports peacetime and wartime operational mission of arranging multimode group/unit transportation to accomplish movement of DoD sponsored personnel GOPAX is governed by Defense Traffic Management Regulation 4500 9 Transportation and Management and NAVSUPINST 4600 70, Transportation GOPAX provides in transit visibility GOPAX is a Web Based system GOPAX is a procurement acquisition business process for the Installation Transportation Offices (ITOs) and commercial carriers across the country. Requests for service from installations throughout CONUS are posted so that MCC, AMC and MTMC can view the requirements Requests for service and offers of service are communicated between MTMC and the carriers/associations Once all offers are received, evaluation takes place, and services are identified, awards and routing information are posted on the web for review by both the carriers and the ITOs After the award is made to the carrier, routing instructions are then posted on the web for viewing by ITO's The movement information is used for monthly management reports as well as various inquiry reports These reports contain Requests for Service from 170 installation transportation offices and 160 commercial carriers located across the country</p>
