	Total Army Personnel Data Base (TAPDB) Background: The Total Army Personnel Database (TAPDB) system is intended to provide a read-only, view of Human Resources (HR) data as a snapshot in time for all Army Military and Civilian level personnel. TAPDB provides read-only data that is refreshed daily (within 24 hours of receipt of data) to support reporting, analysis (no aggregations or time series analysis), and serves as an integrated source of data for the production of data cubes. The primary data access is via queries of the database using COGNOS Catalogs. Certain customers are provided access to perform COGNOS queries to the database and are allowed to go in and look at soldier data on an ad hoc basis. The primary data sources are provided daily for Active and Reserve and weekly for the Guard. The TAPDB is the consolidated source for Human Resource (HR) information (limited to the TAPDB data elements) on all soldiers and civilians from the current Active Enlisted (AE), Active Officer (AO), Army National Guard (ARNG), U.S. Army Reserve, and Army Civilian personnel databases (HQ ACPERS). The overall goal of the TAPDB is to provide the Army with a fully integrated HR personnel database. These records are created and maintained to manage the member's of the active, reserve and National Guard Service effectively. The governing regulations are 5 U.S.C., 301, Department Regulations; 10, U.S.C., 3013, Secretary of the Army; EO 9307 (SSN); and AR 600-8-104, Military Personnel Information Management Records. The output data TAPDB sends to the Personnel Tempo System (PERSTEMPO) is a subset of data from TAPDB that Program Executive Office, Automated Enterprise System (PEO-EIS (Belvoir) has requested. PERSTEMPO is a system that tracks soldier's deployment location
