	<p>TACTICAL PERSONNEL SYSTEM (TPS)</p> <p>BACKGROUND: The Tactical Personnel System (TPS) is a management system that maintains a roster and critical data of personnel deployed in theater of operations. The TPS scans the bar code on the ID cards as soldiers arrive in theater and pulls limited data such as name, rank, social security number (SSN), Primary Military Occupational Speciality (PMOS), Unit Identification Code (UIC), and gender, from the Joint Personnel Data (JPD) that is compiled from the Integrated Total Army Personnel Database (ITAPDB). It also contains data provided weekly by 3d Personnel Command (PERSCOM) (located in theater) that includes SSN, name, gender, DoD Component, Service Branch, UIC, unit, major subordinate command, location in theater, MOS, pay grade, arrival date and flight, and departure date and flight. The data that 3d PERSCOM in theater provides weekly, refreshes the TPS database completely and each refresh is archived. The TPS is a single-user stand-alone database that 3d PERSCOM uses primarily as a manifesting tool. It can be used to record changes to duty status and is more likely to be used at the unit level vs. the theater wide level. It generates weekly outputs on number of personnel that support theater operations by DoD component and Service branch to include military, DoD civilians, contractors, media, Army and Air Force Exchange Service (AAFES), and Red Cross. The TPS augments data received from theater of operations with data from the ITAPDB to enhance queries capability. The Personnel Information Systems Directorate (PERINSD) completes all required TPS queries for the 3d PERSCOM in theater. The (CONTINUED ON NEXT PAGE)</p>

1.	<p>PERINSD also receives weekly back-ups from 3d PERSCOM. When the TPS pulls files from the JPD that is compiled from the ITAPDB, it then converts them to .txt files and imports them into the Joint Theater Personnel Roster (JTPR). The TPS has a maximum capacity of fewer than 50,000 records, but begins to slow down at approximately 2-3,000 records. The proponent of the TPS is the U.S. Army Human Resources Command, PERINSD, Alexandria, VA, and the user is 3d PERSCOM.
