	<p>Independent Stimulation Module (ISM) AR 350-1</p> <p>Background The Independent Stimulation Module is one of 20 constructive training devices used to supplement and enhance live training exercises. Constructive training uses computer models and simulations to exercise command and staff functions. A command post exercise is an example of constructive training. Constructive models and simulations involve training products used by commanders and leaders to train their units. The ISM provides a variety of training environments, allowing multiple scenarios to be replicated under different conditions. Simulated unit input is maintained for the duration of the supported exercise (usually 4 or 5 days) and then purged using prescribed security methods. After action reports and lessons learned documents are produced from simulation training exercises.</p> <p>RN 350-111 Title Independent Stimulation Module Master File Authority TBD PA TBD</p> <p>Description Information consists of simulated unit name, number, reporting headquarters, assignment status and resources, including equipment types.</p> <p>Disposition K2 Keep until record is no longer needed for conducting business, but not more than 2 years, then delete.</p>
