Performance estimates data is entered into AWARS from the Army Materiel Systems Analysis Activity (AMSAA) database. When a study is completed the raw data generated by the system is deleted. The application produces large quantities of statistically generated data which are used for trend analysis. Documents are experiments, studies, exercises, training demonstrations, scenario descriptions, and performance estimates and behavior data.
