	<p>DEPLOYMENT OCCUPATIONAL AND ENVIRONMENTAL HEALTH RISK MANAGEMENT (AR 11-35)</p> <p>Background: The Knowledge-Based Corporate Reporting System (KBCRS) is a web-enabled application whose purpose is to provide online access to corporate information about environmental programs and activities within the Department of Defense (DoD) and its component organizations. KBCRS contains three modules, each serving separate purposes:</p> <p>1) Cleanup Module: A primary objective of the Cleanup module is to collect, validate, summarize, and report environmental site restoration data collected from the DoD Components (Army, Navy, Air Force, DLA, FUDS, DTRA) to generate the Defense Environmental Programs (DEP) Annual Report to Congress (ARC). A secondary purpose is to make the detailed data underlying the various ARCs available to authorized personnel via the web. An equally important objective is to provide authorized knowledge workers with access to a wide range of tools for extracting environmental and/or installation information according to their own individual needs. KBCRS Cleanup users consist of various authorized environmental personnel working for the DoD Components and the DoD.</p> <p>2) MMRP Module: The Military Munitions Response Program (MMRP) module provides access to authorized users to the currently-approved end-of-fiscal-year list of MMRP sites from the Cleanup module. Users are in two classes, reviewers, and viewers. Reviewers include state and federal EPA staff, state and federal land managers, and selected representatives of Native American tribes. Viewers include Cleanup installation POCs and users from the DoD's Environmental Management Office (EMO).</p> <p>3) Solid Waste Module: The Solid Waste (SW) module provides online data entry for solid waste statistics collected from each Component at the Component level, and green procurement data also collected from the Components. Components include the Army, Navy, Marine Corps, Air Force, and DLA.</p>		

The solid waste module generates an Integrated Non-Hazardous Solid Waste report which provides data for the DEP ARC and also generates a green procurement report which addresses the requirements of the Resource Conservation and Recovery Act (RCRA) Section 6002. Users include authorized members of the Component and DoD environmental management staff. Agency programs or units supported by the system include US Congress, All services-DoD Environment, Safety and Occupational Health Community, Federal executive agencies (EPA etc.), Native American Tribal communities, State and Federal Land Managers, General Public (published DEP ARC data only), DoDD 4715.1E, Resource Conservation and Recovery Act (RCRA) Section 6002. All input is electronic format source data consisting of format conformed, validated bulk data extracts from component environmental management systems and manual entry via web forms. Raw input is retained for data Validation and Verification purposes. The principal system output is the Defense Environmental Programs Annual Report to Congress (DEP ARC), generated annually via manual processes from KBCRS data as a PDF file and published to the public on the DENIX system. The proponent of this regulation is the Assistant Secretary of the Army Installations and Environment (ASA I&E).

Description: KBCRS contains DoD wide environmental data generated and maintained by Component organizations.

Cleanup Module: Data is for environmental cleanup sites by installation, cleanup phase and contaminant, funding and cost from 1997 to present.

MMRP module: Data contains site-specific expert commentary and annotations from 2002 to present.

Solid Waste Module: Data for solid waste statistics collected from each Component at the Component level, and green procurement data collected from the Components.

~~**Disposition:** PERMANENT. TP. Keep until no longer needed for conducting business, then retire to the AEA. The AEA will transfer to the National Archives when the record is 25 years old.~~ *Changed per RO's request*

Disposition: PERMANENT. TP. Upon approval of this schedule transfer a pre-accession copy along with related documentation to the National Archives. Thereafter, annually transfer a pre-accession copy along with related documentation to the National Archives. Transfer legal custody to the National Archives when the records are 25 years old.

~~**Description:** Included are user guides and manuals relating to the system architecture, indexing criteria (for retrieval), field definitions, records layout, data elements, and code books that identify and interpret all codes used to record data.~~

~~**Disposition:** PERMANENT. TP. Transfer to the National Archives at the same time related data in the master file is transferred to NARA.~~

Justification: The records contained in KBCRS comprise the DoD Enterprise system of record and authoritative data source for DoD corporate environmental reporting data. As such, the official finalized records would need to be retained permanently to permit long term trend analysis and determine DoD's success in meeting federal mandated environmental compliance goals.
