	<p>55 - Transportation and Travel</p> <p>The U.S. Army Forces Command (FORSCOM) has a key role in the mobilization and deployment process. FORSCOM coordinates unit movement requirements with units, installations, the U.S. Transportation Command and its components, theater commanders, and other joint planning and deployment community members for Joint Chiefs of Staff (JCS) exercises and contingencies.</p> <p>FORSCOM maintains the Army's master files of standard unit movement data, and standard equipment transportability characteristics for the Army table of organizations and equipment.</p> <p>Background. The Computerized Movement Planning and Status System (COMPASS) is a logistical system that provides transportation data to the Department of Defense (DoD), JCS, and other Army organizations in support of movement and deployment operations for active Army, Army Reserve, and National Guard units. The system describes unit property and equipment in transportation terms.</p> <p>The retention of actual unit movement data is the life span of the deployment.
