THREAT ASSESSMENTS (381-11b). Documents pertaining to evaluations of an enemy's current or projected capability to limit, neutralize, or destroy the effectiveness of a mission, organization, or item of equipment. These documents include mission area assessments (MAA) and system threat assessments reports (STAR).

Disposition:

Office performing Army-wide responsibility: PERMANENT.

Other offices: Destroy when no longer needed for current operations.

BACKGROUND: The rationale and justification for the establishment of this file is essential. A requirement exist for Army to have at every level, accurate and current materials for their work to support concept and doctrine development and training development. These documents pertain to all aspects of current threat technology, developments, training, tactics, equipment and organization, and allows the Threat Manager to accurately monitor the threat with support of systems, mission, area analysis, systems program review and functional area analysis, and in addition, allows the threat manager to be aware of changes throughout the life cycle of the system or study.
