**SUMMARY**

The Department of the Army requests disposition authority adding one new item, 700-18a, Provisioning Army Systems Documentation, in its AR 25-400-2 (MARKS). Specifically, the records pertain to such routine matters as Army provisioning of supplies and materiel and guidance on logistics support and budget procedures. These records clearly lack archival value and are temporary in nature. Therefore, I recommend approval of this job as submitted. I have discussed this job with Elaine Everly (NN-E).
