	<p>GAMO Test Procedure Planning Files (FN 235-02, AR 340-18-2). Documents relating to development of test philosophies, proposals, plans, and procedures. Included are coordination actions, recommendations for services/agencies, recommendations regarding implementing actions, and joint interface implementation plans.</p> <p>Office performing Army-wide staff responsibility: Destroy 5 years after discontinuance of activity. Other Offices: Destroy after 2 years.</p> <p>Request authority to establish disposition instructions as stated above for GAMO Test Procedure Planning Files, which accumulate in the Ground and Amphibious Military Operations (GAMO) Management Office, Office of the Deputy Chief of Staff for Operations and Plans, HQDA. The GAMO Program was established by the Joint Chiefs of Staff in April 1971 to develop plans to achieve interoperability and joint operational effectiveness of Tactical Command and Control Systems, and to test and evaluate these plans. The files described above relate to the development and coordination of testing procedures and plans to accomplish compatibility and interoperability between Army, Navy, Air Force, NSA, and DIA Tactical Command and Control Systems. <i>Any permanent items are incorporated in the permanent Interface Planning Files, AR-340-18-2, #235-01.</i></p>
