	<p>GAMO Configuration Management Files (FN 235-02, AR 340-18-2). Documents relating to management and/or standardization of configurations for Tactical Command and Control Systems. Included are proposed changes to data and messages, and data standards, and actions related to those changes.</p> <p>Office performing Army-wide staff responsibility: Permanent. Cut off on discontinuance of activity. Other offices: Destroy after 2 years.</p> <p>Request authority to establish disposition instructions as stated above for GAMO Configuration Management Files, which accumulate in the Ground and Amphibious Military Operations (GAMO) Management Office, Office of the Deputy Chief of Staff for Operations and Plans, HQDA. The GAMO Program was established by the Joint Chiefs of Staff in April 1971 to develop plans to achieve interoperability and joint operational effectiveness for Tactical Command and Control Systems, and to test and evaluate these plans. The files described above relate to the management and standardization of configurations to achieve compatibility and interoperability between Army, Navy, Air Force, DIA, and NSA. Present volume: 8 linear feet Yearly accumulation: 4 linear feet Available for transfer to Archives: 25 years from present date.</p>
