SECTION III -- APPRAISER'S COMMENTS

In the attached SF 115, Request for Records Disposition Authority, the Department of the Army proposes permanent disposition of Counterintelligence(CI)Spot Reporting Files(FN503-06). CI spot reports include information concerning incidents of such importance as to require immediate dissemination. They are issued on all incidents of CI interest involving matters such as sabotage, espionage, or criminal subversion and also when of a CI interest involving personnel, material or facilities. Volume created is small. Since the information in these incidents may have bearing on the security of the United States or its Armed Forces, it would appear to warrant continued preservation.
