SECTION III - APPRAISER'S COMMENTS

In NCL-AU-83-50, the Army requests the expansion of an approved disposition. File Number 1108-32 of AR 340-18-11 already makes disposable postage-meter licenses which military activities receive from the United States Postal Service. The proposed revision would make the Army's copies of applications for such licenses disposable also.

As the retention periods proposed for these merely-facilitative copies will satisfy the Army's administrative needs, I recommend that this request be approved.
