Most of the intelligence data used in precision targeting comes in the form of imagery and satellite data or imagery from remote sensors or cameras, data is then input into the system with the classified BAE software that adds height and dimension to the image that allows for targeting to be completed for various weapons systems using the 3D capabilities within the system.
