This is a flexible schedule that includes but in not limited to to the TPC FoS,Tactical GeospatialInformation Library (TGIL), Deployable GeospatialInformation J Library-Server (DGIL-S), Deployable GeospatialInformation Library-Workstation (DGIL-W),Digital Terrain Analysis Mapping System (DTAMS), Digital Terrain Analysis Mapping System-Light (DTAMS-L), the Geodetic Survey Set (GSS),and future TPC FoS systems. The mission of the TPC FoS is to provide a system's infrastructure, processes, and people to enable robust geospatial information (GI) and geospatial intelligence (GEOINT) applications and data to support battle-space awareness and visualization across all Ranges of Military Operations and geographic regions via tactical networks. The TPC FoS provides the geospatial foundation for the Common Operational Picture (COP) of the battlefield;terrain analysis in support of the Intelligence Preparation of the Battlefield process; all-source terrain data management, collection, processing, exploitation, analysis, integration, dissemination, and storage;as well as briefing and decision-aid development support. It replaced the Topographic Set (TOPOSET).</p>
